Did you know that, if you **Gift Aid your subs**, the Government will pay the WI **25p for every £1 of subs** that you pay.

That's £12.75 per member.

Why waste that money? The WI could make good use of it

With 3,000 members the Gift Aid claim for Wiltshire could total £38,000 (if all members were tax payers), split between your Branch, Federation & National.

Note: You must be a tax payer and pay enough tax to cover the gift aid on all donations you make to charity. Nobody in the WI will know anything more about your finances than that.

All YOU have to do is fill out the form overleaf,

give your name and address and hand it in to your WI Treasurer or send it straight to WI House, 17 Couch Lane, Devizes SN10 1EB. It's a one-off form. It does not have to be done every year but you must tell the WI if you stop paying tax.

Even if your WI Branch does not want to do Gift Aid, Federation does, so please send us the form.
